## The Role for Collaboration and Regional Investment Funds in Advancing Affordability

We will visit the Federal Reserve Bank of Atlanta and discuss the local example of a \$300M investment fund for housing production and preservation, organized by the Community Foundation of Greater Atlanta and other Atlanta stakeholders. We will discuss the strategies, setbacks, and successes of investment collaboration with philanthropic, public and private partners, including CDFIs, in Atlanta and around the country.

## Homeownership and Preservation on Atlanta's West Side

HPN Member Atlanta Neighborhood Development Partnership (ANDP) will showcase examples of single-family housing development in many forms – offered as rental and homeownership opportunities, developed through a land trust and shared equity model, financed with New Markets Tax Credits, and more. We will discuss the community partnerships that have targeted support to legacy residents and aligned affordable single-family housing development with major civic projects in the area.

## **Strategic Investment and Integrated Property Management**

This off-site session will feature Centra Villa, a 132-unit affordable housing development offering permanent housing for veterans along with workforce housing that is owned and operated by Community Solutions. A key feature is that Community Solutions is integrating its "property management plus" model into this property, as well as to a growing portfolio across the country. Community Solutions' President Rosanne Haggerty and the property management team (TI Asset Management) will be on hand to discuss their methodology for connecting tenants to services through the VA, accommodations for residents with special needs, coordination with community services, and the use of social impact capital to enable the preservation of this type of property.

### Affordability on the Belt Line: Housing for Long Time Residents

Mercy Housing's Reynoldstown Senior Residences is an award-winning example of affordable housing for seniors in an area that has seen significant investment and growth in the last several decades. When gentrification and displacement began to pick up, longtime residents came together to advocate for affordable housing, hoping to be able to stay in their historically Black neighborhood that has been home to generations of families and community leaders. Against the backdrop of the Atlanta Beltline, a multi-use trail and light rail transit system on a former railway corridor, this development offers one example of use of the Beltline's Affordable Housing Trust Fund.

#### A "One Stop Shop" for Ending Homelessness: Community Partnerships and Affordable Housing

Mercy Housing's Thrive Sweet Auburn showcases creativity, community engagement and collaboration at a development that brings together affordable housing, office, commercial and amenity space. On-site offerings include medical care, support services, a community kitchen, nonprofit offices, a coffee shop, and more. Mercy Southeast will be joined by local partner Project Community Connections, Inc. to walk through the development, including a mix of permanent supportive housing and affordable units, and discuss strategies for successful colocation and service delivery.

## Investing in the Future: Partnership with and Investment in BIPOC Housing Developers

This session will focus on the strategies and steps to ensure financial stability and operational strength for properties, portfolios, and organizations. We will share strategies and approaches to addressing "problem properties" and the impact these have on their organizations. How do we make the difficult decisions that ideally provide stability for both and ensure the best outcome for the organization.



### Seizing the Moment: Leveraging Climate Resources for Housing Preservation and Production
